Dear Sir;

The Port McNeill Timber Sales Office (BC Timber Sales Seaward Business Area) would like to invite the District of Port Hardy and the Tsulquate Watershed Stakeholders group for a meeting to review planned BC Timber Sales operations within the Port Hardy Community Watershed in the vicinity of the Tsulquate River.



BC Timber Sales is proposing the development of block PHhd977which would include an estimated 15 hectares of forest harvesting and an estimated 1.5km. of road construction within the Port Hardy Community Watershed. The Seaward Forest Stewardship Plan commits our operations to conforming to the Government Objectives for water in Community Watersheds under the Forest and Range Practises Act, which includes ensuring that our operations are not materially affecting the quantity or the quality of water available from the community waterworks. We would like to discuss with the District of Port Hardy and with the Tsulquate Stakeholders how we can successfully develop block PHhd977 such that it will conform to the Government objective as well as our Forest Stewardship Plan commitment. The enclosed mapping illustrates the proposed location of cutblock PHhd977 and associated road access.







PREAMBLE

The Council for the District of Port Hardy receives a large number of proclamations from local, provincial and federal groups and organizations each year, requesting support from the Mayor in proclaiming or recognizing specific events, days, weeks or months.

Each year the number of proclamations increases and many are submitted from organizations who have no local or regional affiliation and whose requests are not always clearly presented or understood. Some requests for proclamations do not include a sample proclamation, requiring staff time to draft the proclamation

POLICY

- 1. Council will consider requests for proclamations when they are supported by a local organization
- Requests for proclamations from organizations without a local aponsor may be considered if sponsored by a member of the District of Port Hardy Council.
- 3. The request for a proclamation must include a draft proclamation
