A. CALL TO ORDER

Mayor Bood called the meeting to order at 1:30 pm

B. APPROVAL OF AGENDA

C. DELEGATIONS

 Greg Fletcher, Administrator, Regional District of Mount Waddington (RDMW) re: services provided to Port Hardy by the RDMW

Mayor Bood introduced Greg Fletcher, Administrator for Regional District of Mount Waddington (RDMW). Mr. Fletcher used a power point presentation (attached to these minutes) to provide an overview of the services that the RDMW provides to the District of Port Hardy.

The review included information on:

- Board composition and area representation
- Regional services by population and assessment
- Regional and sub-regional service types and participation
- 2015 Port Hardy requisition
- RDMW regional services cost and Port Hardy's share of those costs

Mr. Fletcher conducted a review of each of the regional services including:

- Regional Hospital District;
- North Island 911 Corporation 911 emergency call answering service;

Councillor Pat Corbett-Labatt asked if Telus could provide better cell service coverage between Port Hardy and Campbell River in those areas where cell service is not currently available, although in these same areas 911 coverage is available. Greg Fletcher advised Telus set up costs are high but that by sharing

facilities it could be a possibility if the two corporations were willing to work together.

- Regional Emergency Planning;
- Regional Parks
- Regional Economic Development;

Mayor Bood commented that at the time he left the Mayor's office in 2006, the District did not participate in the regional economic or regional planning functions. He advised that the \$50,000 cost to participate in those functions should be reviewed by Council.

Councillor Marcotte commented he was surprised that Mayor Bood would be making comments regarding Port Hardy participation in these functions at this venue and suggested that any discussion on that topic be conducted at a future Council or strategic planning meeting.

Greg Fletcher advised that economic development initiatives are more successful when supported regionally. He advised that the downside to Port Hardy is that if there is no participation in a service, then Port Hardy does not have say in decisions in these areas that affect the region.

Council also discussed with Mr. Fletcher how regional economic development is benchmarked, how other areas are being affected by the closing of management offices in the forestry and aquaculture sectors, and other regional district economic development situations and models.

Regional Planning;

Mr. Fletcher described the breakdown in regional versus rural planning services. he discussed the advantages of participating in regional planning, the region wide GIS System that is in place, collaboration with local First Nations and how planning works hand in hand with economic development to help leverage economic development goals and objectives.

Mayor Bood commented that the District has a small role in rural planning.

Jeff Long, Director of Corporate and Development Services, clarified the breakdown of the planning function, the costs associated with regional versus rural and the optionality associated with the services. In reference to the rural portion of the planning service, he asked Mr. Fletcher if it would be possible that in the RDMW's dealing with Crown land referrals perhaps those that reflect special interest for Port Hardy could also be forwarded to Port Hardy and that Port Hardy comments be included in the RDMW response back to the Province. Mr. Fletcher commented that Crown referrals are only sent to Port Hardy if the referral affects an area in proximity to Port Hardy.

- Solid Waste and Associated Carbon Credits;
- Transit

Mayor Bood opened the floor to questions from Council.

Councillor Marcotte asked if Namgis and other treaty negotiations and settlements in the RDMW will have an on regional services and cost sharing of these services.

Greg Fletcher advised that treaty / land settlements may have an impact on tax base. He cited the Kokish River hydroelectric project being on Crown land at present which is taxable for the RDMW, and if this land should become Namgis land as part of a settlement, it may no longer be part of the tax base and therefore, service costs would go up for other benefitting properties. In this discussion, Mr. Fletcher touched on participation in treaty talks. Councillor Robertson asked if the RDMW Board members that participate in such talks report back to their respective councils. Greg Fletcher advised and Mayor Bood corroborated, that treaty meetings are similar to in camera meetings and the Province requires that information discussed is not to be shared outside those meetings.

Councillor Robertson apologized for being late and asked how much attention is given to recreational planning in the RDMW. Mr. Fletcher advised very little and that anything that is undertaken is largely done off the side of staff's desks.

Given the arena arrangement in Port McNeill, Councillor Marcotte asked how the RDMW would feel about taking over the District's indoor pool and arena.

Mr. Fletcher advised that t is not so much a factor about what the RDMW feels, but rather what the RDMW taxpayers would feel about that.

Councilor Pat Corbett-Labatt advised that the Port Hardy pool is the only indoor pool on the North Island and it is used by all communities. She indicated the pool is in need of repairs and upgrades that are of financial significance to the District.

Mr. Fletcher advised that a pitch to take over the facilities would have to be made to the area directors and regional taxpayers and that a public process such as a counter-petition or referendum would be required. Mr. Fletcher advised that Mayor Parnham had started work on this initiative, particularly with local First Nations who could be key factor in the voting mechanism that is required to proceed.

Mayor Bood advised that in the past Port Hardy has been able to access funding from the Federal Government vis-à-vis the Department of Indian and Northern Affairs Canada.

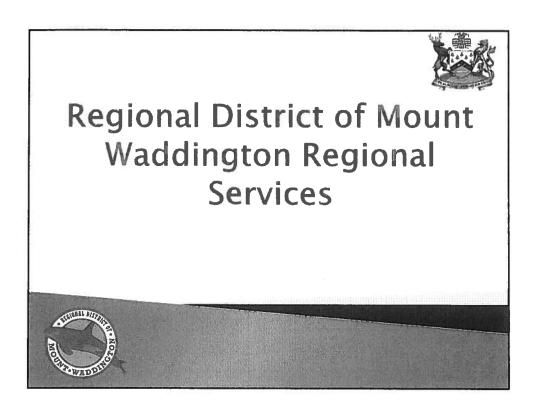
Rick Davidge, Chief Administrative Officer, advised that the local First Nations have more resources today, but given the recreational facilities are located off reserves is an issue.

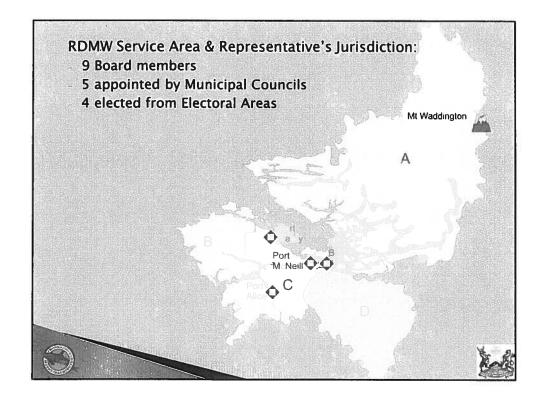

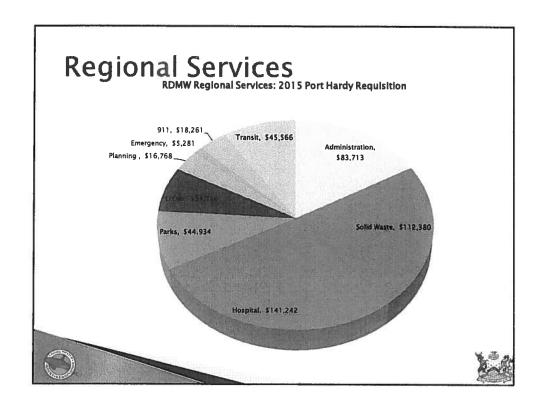


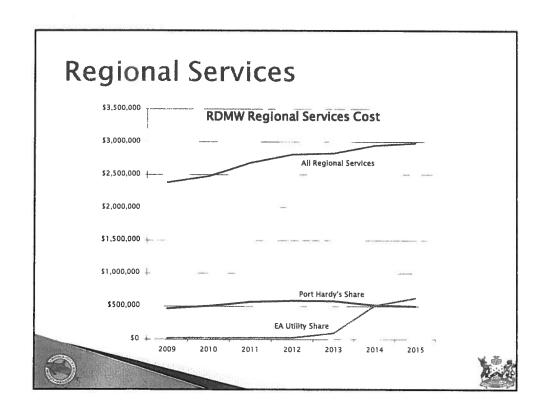
Regional Services

- ▶ 1 Sub Regional Services: Transit (6 of 8 areas participate together with 4 First Nations)

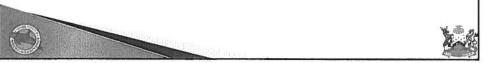






Regional Services: Regional Hospital District

- ▶ Established in 1967
- Provides approx. 40% of capital costs for Hospitals & other health care facilities provided by VIHA, including new Port Hardy Primary Care Facility
- → 2015 \$643,000 Cost Recovery from Local Government Property taxes (100%)
- Includes administrative support services for the Mount Waddington Community Health Network



Regional Services: 911 call Answering Service

- > 911 Corp Established in 1995
- Owned by 6 Regional Districts
- Provides emergency 911 call answering to entire RDMW, including all First Nations
- ▶ \$89,000 is RDMW share of Cost Recovery from Local Government Property taxes (100%)





Regional Services : Regional Emergency Planning

- ▶ Established in 2005
- Includes 6 First Nations, 4 Municipalities & 4 Electoral Areas; participation by mutual aid agreement
- Regional Emergency Plan Coordination; includes cost of coordinator, training, exercises & meetings
- ▶ \$26,500 Cost Recovery from Local Government Property taxes (100%)
- Port Hardy is a participating voting member of NIREPC which meets 3 times per year





Regional Services: Parks

- Established in 1972
- Maintains parks and recreation sites including campsites such as Link River and Bere Point and day use sites including Little Huson Caves
- Includes support for Mount Cain and the 7 Hills Golf Course
- Quatse River is run by contract
- ▶ 2015 \$249,000 Cost Recovery from Local Government Property taxes (100%)

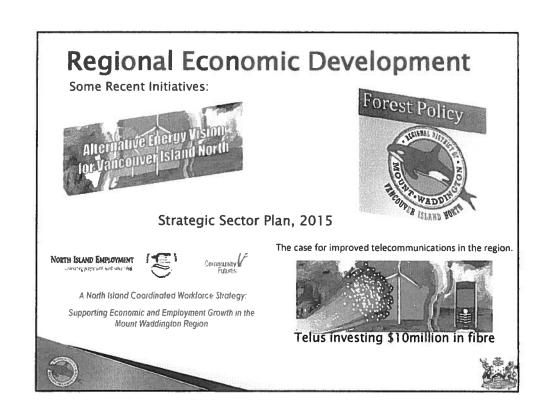


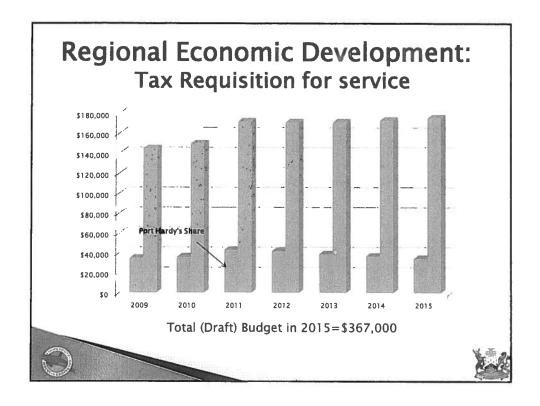


Regional Economic Development

- Economic Development was regionalized in 2006 to:
- Include North Island Tourism which provides tourism promotion & coordination for the entire North Island
- Supports the retention and attraction of working families within the Regional District through sustainable job creation.
- Increased regional development dialogue and partnerships between communities and First Nations through the North Island Regional Protocol Agreement.
- Education and training coordination addressing local labour market supply and demand, institutional inefficiencies and actively attracts new learners.
- A healthy, fairly assessed, regional tax base
- A healthy mixed economy of primary, secondary and tertiary industries that support a strong regional economy through diversity.



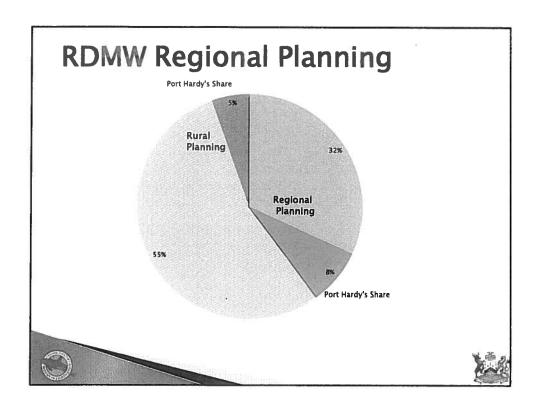




RDMW Regional Planning

- Provides and maintains Regional GIS System that is available to all Municipalities

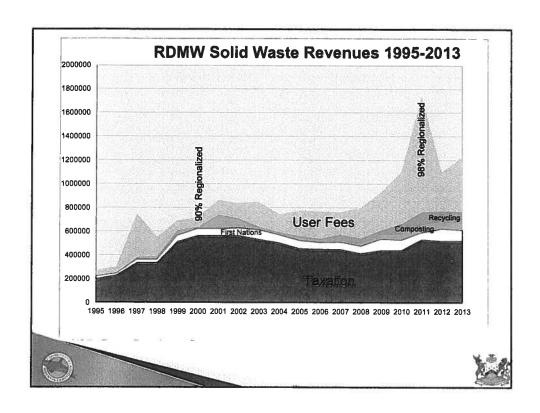


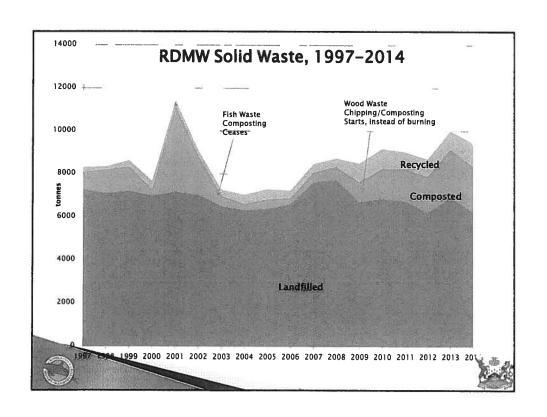


Regional Services: Solid Waste

- > Established in 1995
- Includes 4 First Nations, 4 Municipalities & 4 Electoral Areas
- Solid Waste Disposal, Recycling depot & processing, bulk composting & carbon recovery
- Cost Recovery (2015) from user fees (25%), Local Government Property taxes (50%) First Nations per capita assessments (11%) & Recycling revenues (9%)
- ▶ Total Est 2015 Cost \$1,102,000







Regional Services: Solid Waste Carbon Credits



- RDMW & Municipalities are signatories to Climate Action Charter (CAC) committing to carbon neutrality by 2012
- RDMW developed a bio-cover system using composted biosolids & woodwaste to reduce methane emissions from 7 Mile Landfill...eligible for carbon credits
- RDMW achieved carbon neutrality in 2012
- Credits distributed to service CAC signatories & reserved for First Nation service partners
- Port Hardy received 177 tonnes carbon credit in 2013

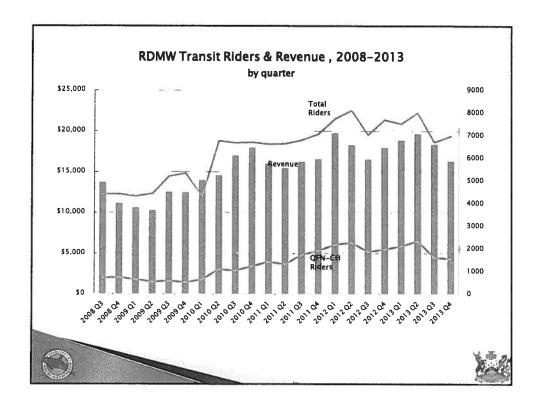

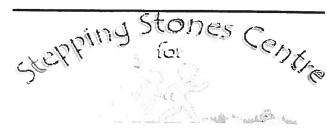

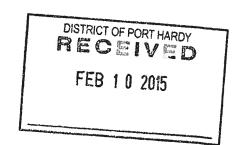

FEE FOR SERVICE / HONORARIUMS / GRANTS-IN-AID

POLICY # CP2.7

Approved: July 10, 1996 Last Amended: June 12, 2007

Page 1 of 1

A. Council must in its annual budget allocate funds for disbursement to non-profit groups which would be evaluated on individual merit. The donation may be made in kind or cash.

District advertising of the grants-in-aid policy will be done in May and August for the next budget year.

Requests for grants-in-aid must be made in writing by the September 30th for consideration for the next budget year.

Requests will be reviewed upon submission. Individual merit and available funds will dictate Council's decision.

An application for a grant-in-aid will include the following:

- 1) Detail of how the assistance is to be used.
- 2) A recent financial audited statement.
- 3) Detail, if necessary, the use of fund being raised.
- B. Receipt of Late Grant in Aid Application

The Council may consider a late Grant in Aid application only if unallocated funds remain in the Grant-in-Aid Budget.

Requests will be forwarded to the Director of Financial Services for determination of available funding. If funding is available, the DFS will forward the application to Council for consideration.

C. Requests for Discounts on User Rate Fees

The District of Port Hardy will not consider requests for discounts for recreation fees, moorage or any fees that are set by bylaw.

Upon receipt of requests, staff will:

- 1. advise the organization requesting the discount of this policy; and
- 2. provide them with information on the District's Grant In Aid Policy

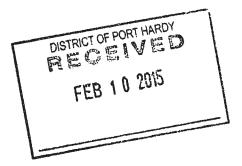

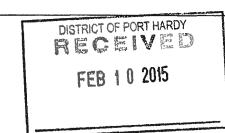

Dear Mr. Natale,

The North Island constituency, which I have represented for 10 years, relies strongly on Telus for much of its telephone, mobile and internet services. I am very aware of the investments being made, in conjunction with government, on fibre optic and cell services.

However there are still some very serious gaps which I would hope that you would assist me in addressing.

Internet Connectivity

As the President of a large telecommunications company, you are perhaps more aware than most of the need for high quality broadband coverage. It is as fundamental for community economic and social well being as electrification was years ago. While a new cable has been laid from Sayward to Port McNeill, other communities are still struggling: Port Alice continues to have a waiting list for service and Port Hardy's service is achingly slow now and there is no guarantee for broadband level coverage when the new service starts. This hampers industrial and community development. It impacts the delivery of health and education. It is essential that these communities are not limited by their ability to access the internet.

Likewise the populations of Quadra and Cortes Islands have very patchy services. A few on Quadra receive Telus service; most rely on a cable company or satellite.

While much traffic is now done through smart phones and wireless technology, this is not the solution for a whole community.

Cell Coverage

The North Island is a rural constituency. The main urban centre is Campbell River but there is a density of population in other areas and there are many isolated roads.

The remote nature of the communities was perhaps highlighted a couple of weeks ago when there was a serious accident on Highway 19 between Woss and Sayward. A teen was trapped in a vehicle for several hours. The lack of cell coverage on the highway meant no-one who stopped to assist could call emergency services. It was only when a logging truck pulled over that a radio call was made.

There is no cell coverage for the 195km of Highway 19 between Campbell River and Port McNeill nor on the 90km of Highway 28 between Campbell River and Gold River. Other communities, including Tahsis and Zeballos, have neither connection on their roads or in their communities.

Pager Service

Because of the lack of cell connection, emergency services in our communities still rely on pagers. I have learned through the media that Telus is considering ending its pager service. I would urge that this not be done; this is often the only way that our emergency responders, our volunteer firefighters and our paramedics can get their calls. The risk to public safety and community health with this loss would be huge.

BC is a rich and diverse province with huge opportunities, but there needs to be equity in the treatment of our communities. Technology is changing rapidly; people who work and live in rural communities have no less need for the speed and innovation, for reliability and safety, than those who live in large urban centres.

I would be very happy to meet with you to talk about strategies to ensure my constituents, and others living in rural communities, can get the connections they need to have their safety considered and to live productive lives.

DISTRICT OF PORT HARDY BYLAW NO. 1038-2015

A Bylaw to Amend District of Port Hardy Emergency Program Bylaw No. 17-2007

WHEREAS the Council of the District of Port Hardy deems it expedient to amend Bylaw No. 17-2007;

NOW THEREFORE the Council of the District of Port Hardy in open meeting assembled enacts as follows:

PART 1 CITATION

1.1 This bylaw may be cited for all purposes as the "District of Port Hardy Emergency Program Bylaw Amendment Bylaw No. 1038-2015".

PART 2 AMENDMENTS

- 2.1 District of Port Hardy Emergency Program Bylaw No. 17-2007 is hereby amended as follows:
 - a) The definition "Deputy Emergency Coordinator" is hereby added to section 2.a) as follows:
 - "Deputy Emergency Coordinator" means that person so appointed by the Emergency Coordinator to assist the Emergency Coordinator, including acting in the capacity of the Emergency Coordinator during an emergency situation wherein the Emergency Coordinator is not available to do so.
 - a) The definition "Emergency Coordinator" is hereby deleted and replaced with the following new definition of "Emergency Coordinator" as follows:
 - "Emergency Coordinator" means that person so appointed by Council to undertake the duties and responsibilities as outlined herein.
 - b) Section 3.a) is hereby deleted and replaced with the following new section 3.a):
 - The Council shall appoint an Emergency Coordinator and the Emergency Coordinator may in turn, appoint a Deputy Emergency Coordinator.
 - c) Section 3.b) is hereby deleted and replaced with the following new section 3.b):

There shall be an Emergency Planning Committee which shall meet not less than quarterly, with the Emergency Coordinator acting in the capacity of chairperson. The Emergency Planning Committee shall consist of:

- i) Emergency Coordinator;
- ii) Council representative;
- iii) Emergency Operations Centre Director or designate;
- iv) Emergency Social Services Coordinator; and,
- v) Any other persons the Emergency Planning Committee may deem appropriate.
- d) Section 3.c) is hereby deleted and replaced with the following new section 3.c):

There shall be a District of Port Hardy Emergency Plan approved by Council which shall provide the direction and framework to deal with the prevention, preparedness, response and recovery programs to cope with major emergencies and disasters. The Emergency Planning Committee may initiate reviews of all or part of the Emergency Plan and amendments thereto shall be approved by the Emergency Planning Committee.

e) Section 4.b)xii) is hereby deleted and replaced with the following new section 4.b)xii):

in an emergency situation, initiate contact with the Provincial emergency program agency to obtain a task number related to said emergency situation.

PART 3 SEVERABILITY

3.1 If a portion of this Bylaw is held invalid by a court of competent jurisdiction, then the invalid portion shall be severed and the remainder of this Bylaw shall be deemed to have been adopted without the severed portion.

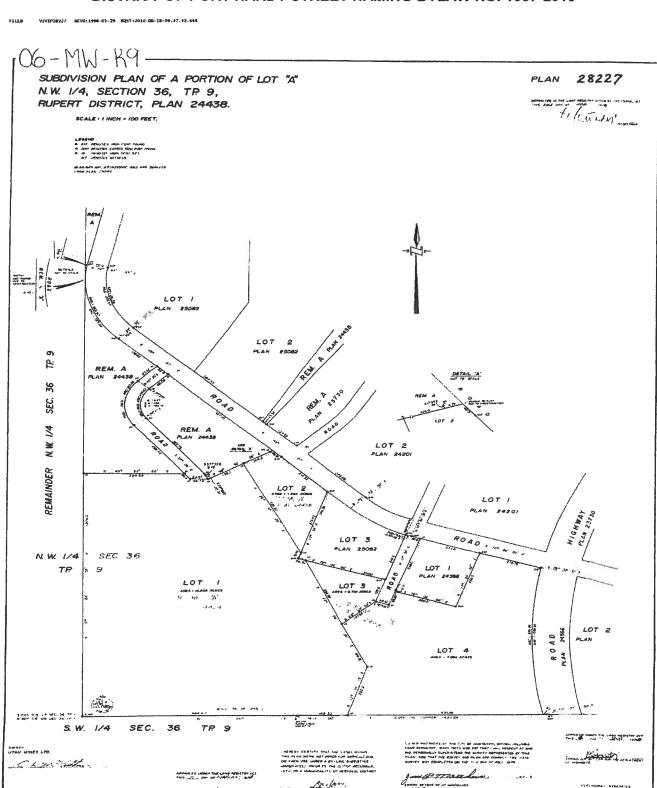
